 - Be a current Professional member of IKYTA or your country's National Teacher's Association.
 - Have a strong personal practice of Sadhana and Kundalini Yoga and where possible to participate in group Sadhana.
 - Have attended at least one KRI, Sikh Dharma, or 3HO Event every year for the past three years including but not limited to Solstice, Teacher's Conference, any Yoga Festival, Women's Camp, Jaap Sahib, Level Two Training, Trainers Forum, White Tantric Yoga.
 - Contribute Gurudakshina either internationally or to your National Association or contribute to The Yogi Bhajan Library of Teachings
 - Has been accepted by Mentoring Lead Trainer
 - Yogic lifestyle

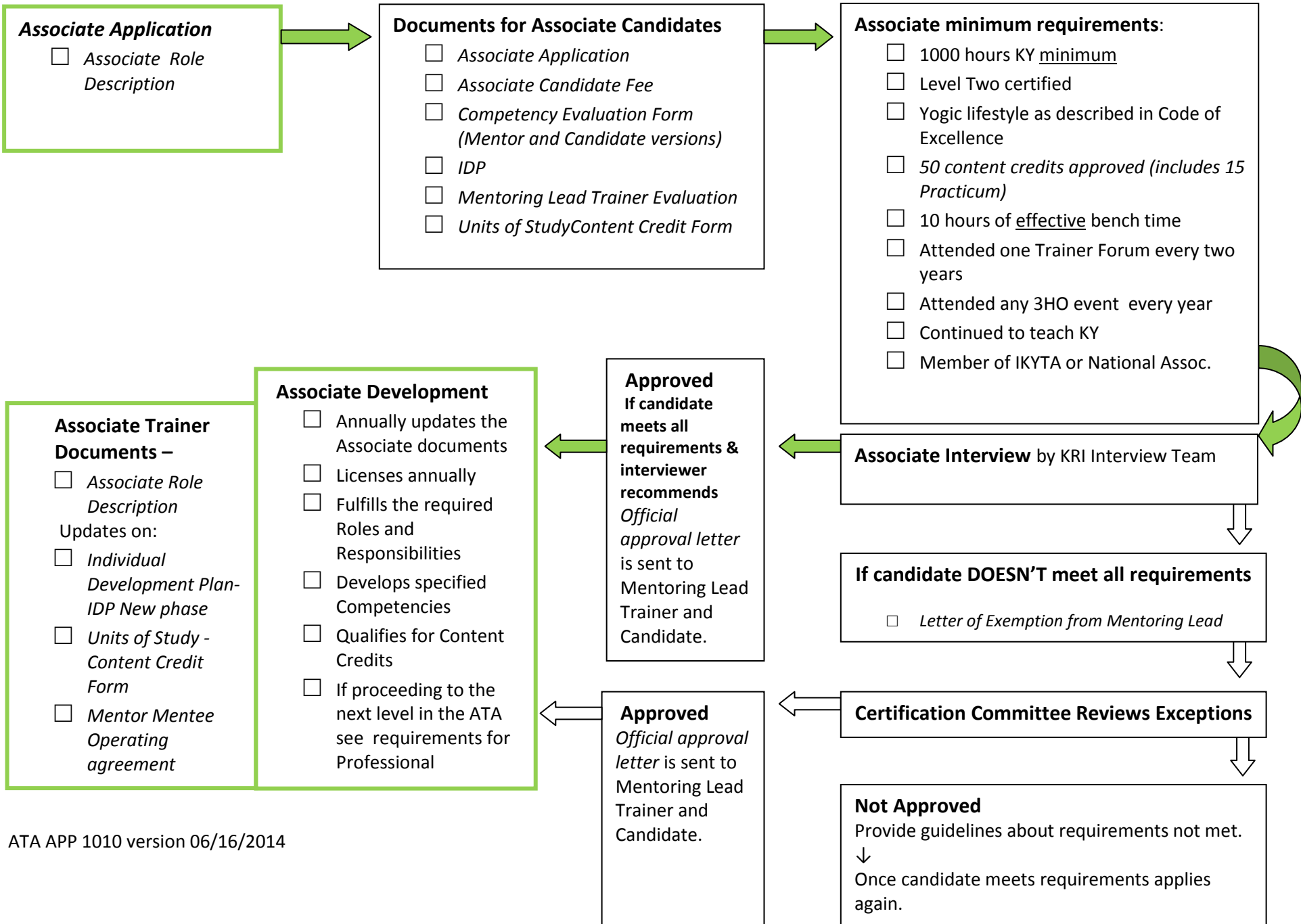

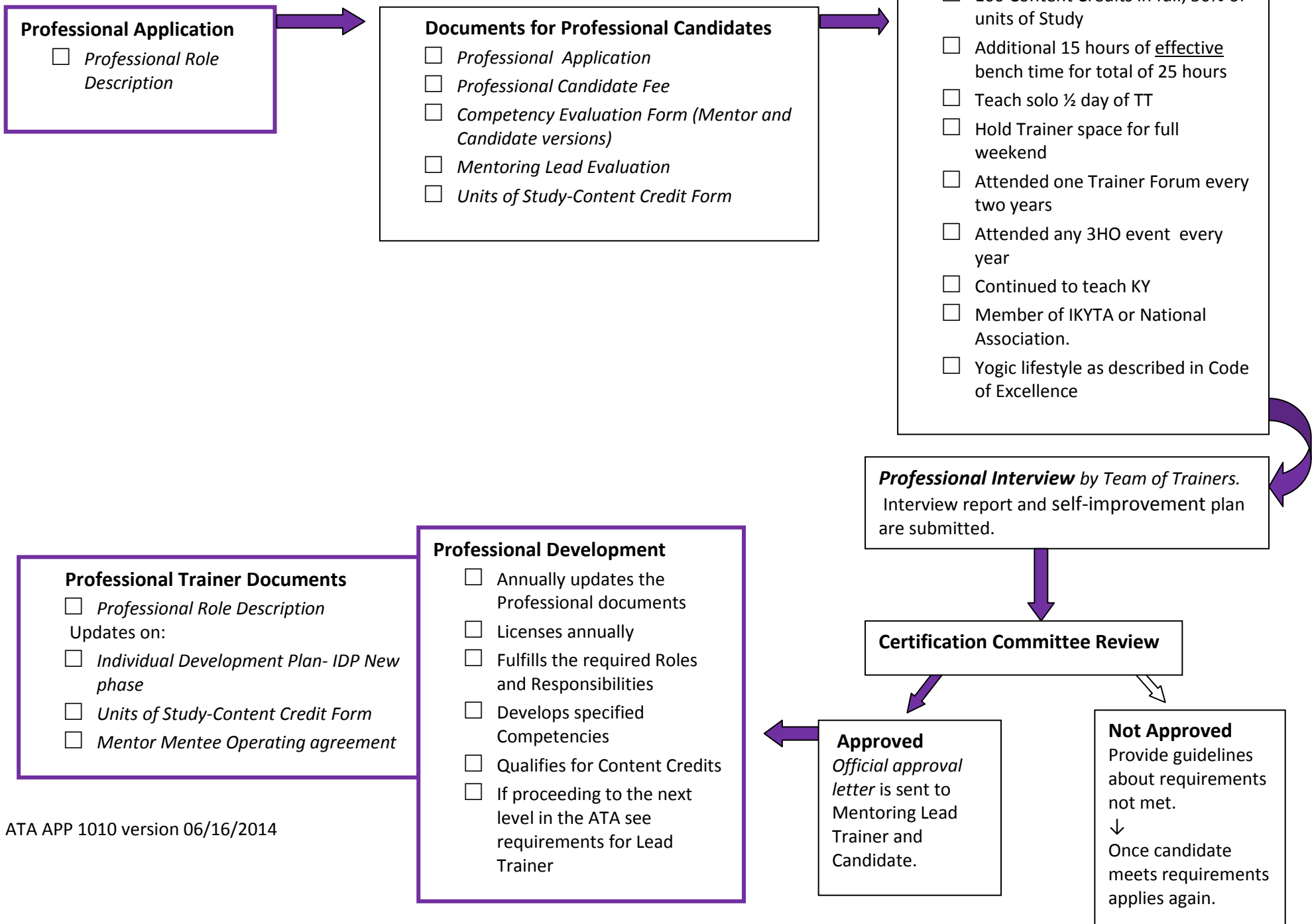
